

RAIN COLLECTIVE & FREE KICKS SWEEPSTAKES

OFFICIAL RULES

1. NO PURCHASE NECESSARY TO ENTER OR WIN.

2. HOW TO ENTER: Participants may enter from Friday February 23rd, 2024 at 8:00 am eastern standard time through April 10, 2024 at 6 pm eastern standard time. Participants can log on to www.araincollective.org/free-kicks-sweepstakes and follow the on-screen entry instructions for the Free Kick Inter Miami vs New England Revolution Sweepstakes. There are two ways to enter the sweepstakes:

The **first** entry pathway requires the participant (1) make a \$50 minimum donation to the Rain Collective (RC) for use in addressing human trafficking in the Middle East and (2) to (a) follow the Rain Collective on Instagram, LinkedIn or Facebook and ‘like’ the sweepstakes post and (b) share or repost (with a tag to RC) the promotional post about the sweepstakes.

The **second** method for entering the sweepstakes is by (1) downloading the required form from www.araincollective.org/free-kicks-sweepstakes and mailing the completed form to: PO Box L Berlin, CT 06037 and (2) (a) following RC on Instagram, LinkedIn or Facebook and ‘liking’ the post about the sweepstakes and (b) sharing or reposting (with a tag to RC) the promotional post about the sweepstakes. You may enter only twice per physical home address of the participant, but promoting the sweepstakes is only required once.
